Dear Non-Food Vendor,

On Saturday, October 6, 2018 the Borough of Eatontown will be hosting the ninth annual "Eatontown Community Day" at Wolcott Park. The day begins at 1pm and will conclude at 5pm. The past eight years were great, but we are going to make this year even better! This event is turning into a great fun-packed day with the participation of both civic and commercial Eatontown organizations. We have scheduled activities for all ages, small fair type games, music and entertainment along with delicious picnic type food. Our theme again this year will be a Fall Harvest and will feature a hay ride and various other fall activities.

Our event planning committee is comprised of Eatontown Council, Recreation, Police, Fire, First Aid and Department of Public Works members and citizens from the Borough that have shown an interest in making this a new town tradition. We encourage all community groups to join us and show their Eatontown spirit!

The fee for non-food vendors is \$25. Please make checks payable to the Borough of Eatontown and write "Eatontown Community Day" in the memo. Parking for vendors will be communicated as the date gets closer. Please note that vendors are expected to stay the duration of the event – until 5pm. Due to the demand of this event, vendor forms are required to be turned in by September 18, 2018. Any forms received after that date will be accepted at the discretion of the planning committee.

Because we will have DJ and musical acts, vendors are not permitted to play their own music. No electricity will be provided and vendors are responsible to provide their own tables and canopies. Any tent or canopy covering must meet our local codes. In order to ensure we run an organized event, please note that your application will NOT be considered complete until you have returned the form below AND signed the hold harmless/indemnification agreement. Once this has been done, we will issue you your parking pass with parking and unloading instructions. You will be permitted to enter the park at noon to set up. The rain date for our event is October 13, 2018.

HOLD HARMLESS/INDEMNIFICATION AGREEMENT
