WAIVER & RELEASE

- 1 I understand, accept, and assume the risks associated with participation in any and all activities. I also assume the responsibility of conducting myself in a civil manner that is mutually beneficial to all participants. Unacceptable conduct generally includes, but is not limited to, produce theft, tool theft, damage to property beyond gardening, and any conduct in violation of local ordinance or the State Code of Criminal Justice.
- 2 I assume full responsibility for any injuries which may occur to me, as well as the safety of my family and guests, and do hereby fully and forever discharge and release the Eatontown Community Garden (ECG) and the Borough of Eatontown, its employees, board members, officers, agents, authorized volunteers, representatives, consultants, insurers and sureties, and their successors and assigns (collectively, the "Released Parties") from any "Claims." "Claims," as used in this document, mean any and all claims, demands, damages, rights of action or causes of action, present or future, whether the same be known, anticipated or unanticipated, resulting from or arising out of my presence or the presence of my family members and guests at the garden, activities at the garden, the use or intended use of the garden, and/or participation in activities connected with ECG including, without limitation, any of the foregoing resulting from or arising out of the negligence of a Released Party. Further, I hereby waive any and all Claims against a Released Party.
- 3 I expressly acknowledge that participation in the community garden is for my purposes and convenience and not for the purpose and convenience of any one or more of the Released Parties.
- 4 In the event that a dispute arises between gardeners and a resolution of the dispute cannot be reached by the parties, I agree to have the Community Garden Steering Committee act as the arbitrator of the dispute. In the event a dispute arises between gardeners and the designated Garden Committee, the Borough Administrator or his/her designee will serve as the arbitrator and any decisions will serve as final.

I, \_\_\_\_\_, have read and agree to abide by the terms and responsibilities of the Eatontown Community Garden as stated in the "Garden Rules, Policies & Responsibilities" as well as on this "Waiver & Release," and I understand that failure to do so may result in loss of my right to garden.
