

BOROUGH OF EATONTOWN
COUNTY OF MONMOUTH, STATE OF NEW JERSEY

AMENDING CHAPTER 150 ENTITLED "FEES" SECTION 17 ENTITLED "COMMUNITY GARDEN" OF THE BOROUGH CODE,
SETTING FEES FOR GARDEN AISLES .

WHEREAS, the Borough developed a Borough Community Garden and the public has embraced the Community Garden resulting in wide-spread community participation; and

WHEREAS, the Borough created the Community Garden Advisory Committee to oversee the operation and planning of the Borough's Community Garden; and

WHEREAS, under the Borough Code, the seasonal fee for use of the Community Garden is \$25 per 4' x 20' plot and \$15 per 4' x 10' plot; and

WHEREAS, the Community Garden Advisory Committee recommended that the Borough adopt a seasonal fee for the use of aisle plots at \$12.50; and

WHEREAS, the Borough Council believes it is in the best interest of the Borough to adopt an aisle fee.

NOW, THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Eatontown, County of Monmouth, State of New Jersey that the Borough Code is hereby amended as follows:

Chapter 150 entitled "Fees" Section 17 entitled "Community Garden" of the Borough Code is amended as follows (additions are underlined; deletions are ~~stricken~~):

§ 150-17 Community Garden.

A. Use fee. There shall be a use fee for each applicant seeking use of a plot for gardening purposes at the community garden located at Husky Brook Park as follows:

- (1) A use fee of \$25 per gardening season for a garden plot of four feet by 20 feet per applicant.
- (2) A use fee of \$15 per gardening season for a garden plot of four feet by 10 feet per applicant.
- (3) A use fee of \$12.50 per gardening season for a garden aisle plot per applicant.


BE IT FURTHER ORDAINED, that

- A. All other Ordinances or provisions of the Code of the Borough of Eatontown or parts thereof, which are inconsistent with any provisions in this Ordinance, are hereby repealed to the extent of such conflict or inconsistency.
- B. If any provision or portion of this Chapter is held to be unconstitutional, preempted by Federal or State Law or otherwise invalid by any court of competent jurisdiction, the remaining provisions of this chapter shall not be invalidated.
- C. This Ordinance shall take effect upon its passage and publication as required by law.
